These issues include inequalities in health and care, particularly from a gender and socio-economic perspective; and integrated care for older people. RESEARCHER FOR THE HEALTH AND CARE UNIT

- Location: Vienna, Austria
- **Starting date:** Earliest possible date on the 1st quarter of 2022 for an initial duration of 1 year with the possibility of prolongation to open-ended contract (conditional on performance).
- **Closing date**: 18th October 2021
- **Interview dates**: 22nd to 26th of November. Interviews will be conducted face-to-face or online depending on travel restrictions in place due to the COVID-19 pandemic.

Main responsibilities:

- In-depth comparative research on long-term care and health, including policy analysis on inequalities in health and care and integrated care.
- Carry out quantitative OR/AND qualitative research on, for example, health outcomes, determinants of health, informal care and quality of care provided.
- Contribute to project acquisition including identifying appropriate funding opportunities and designing and drafting of research proposals.
- Contribute to the coordination, management of and communication with national and international networks of researchers and teams of experts.
- Contribute to the publication of research findings, namely in high-impact peer-reviewed journals and dissemination of findings to policy-makers through high-quality policy reports and briefs.

Candidate profile

- PhD or an equivalent degree in Economics, Sociology, Ageing Research, Social Policy, or related disciplines. The doctorate shall have been obtained no longer than four years before the starting date of the employment. Experience in applied research would be an asset.
- Proven expertise or track record of publications (e.g. peer-reviewed articles) on inequalities in health and care AND/OR integrated care for older people. Knowledge of long-term care and/or health systems and policy in Europe. Capacity to translate research findings to policy audiences would be an asset.

- Excellent methodological skills in either qualitative (such as content analysis, participatory research, case study or others) OR quantitative research methods (such as sequential analysis, multi-level models, decomposition analysis or others) OR both.
- Team spirit and ability to work in a multicultural work environment on a range of interdisciplinary research projects in the areas described above. Flexibility and ability to work autonomous and meeting tight deadlines.
- Fluent English speaker (oral and written), knowledge of other European languages, namely German, would be an asset.
- Experience of applied research in the relevant fields with a proven record of carrying out own research projects. Experience in acquisition and project management would be an asset.

The European Centre offers flexible working hours and home office arrangements and an attractive remuneration scheme, ample possibilities for supported professional and academic development, independence and autonomy at work.
